

TERMS & CONDITIONS – SPOT THE DOT COMPETITION

2. The competition is open to all Riverside Mall shoppers. A minor who enters the competition undertakes that he/she does so with his/her parent's/legal guardian's consent.
3. No director, member, partner, employee, agent, consultant, promoter, supplier or anybody directly or indirectly involved in this competition, and any spouse, life partner, immediate family member, business partner or associate of such person is allowed to participate.
